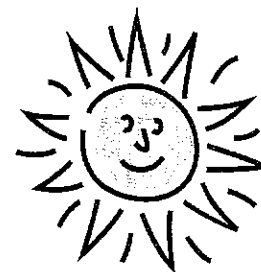

I understand and agree that neither this application nor any other (oral or written) policy statement of the North Suburban YMCA is intended to be or creates a contract of employment or other contract right(s) in me. If offered employment, I understand that the employment offered is subject to termination by the North Suburban YMCA or me at any time, with or without cause or prior notice. I also understand that no one has authority to offer me employment other than "terminable at will" employment.

I understand that, if hired, my employment will be subject to a 90-day evaluation period, and that completion of the 90-day evaluation period does not in any way alter the "terminable at will" nature of my employment.

If hired, I will comply with the North Suburban YMCA policies, rules and regulations and I understand that my agreement to comply with those matters does not create contract rights in me.

I understand that federal law requires the North Suburban YMCA not to employ the individuals who are not authorized to work in the United States.
